This race offers a 10K & 5K on a beautiful and scenic course over both roads and trails with ocean vistas along the way.

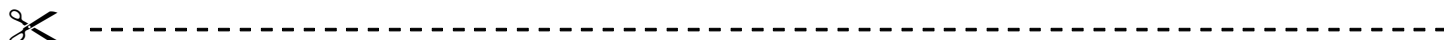

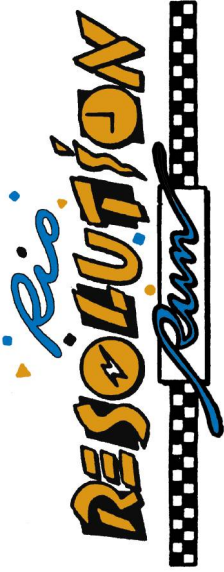
